As a service to our customers a list of certified testers active in the local area is provided. You may also find Assembly Testers listed in the Yellow Pages of the local telephone directory under, "Backflow Prevention Devices & Services", "Plumbing Contractors", "Sprinklers Automatic Fire Commercial & Industrial" and "Sprinklers Garden & Lawn, Installation & Services". A listing of certified testers active in the local area is available at the City's Utility Department website; fortsmithwater.org. From the home page click on Cross Connection and choose Tester Technicians. The City of Fort Smith is not associated with Assembly Tester Technicians, and therefore, cannot regulate the fees charged and derives no monetary benefit from these fees. It is recommended that you contact multiple Assembly Tester Technicians and compare prices before scheduling a test. **In addition; it is the Customer's responsibility to insure that the Testers certification is current and their equipment has a current calibration. The City of Fort Smith will not accept a test from an expired Tester or a Tester with expired equipment calibration.**
